TERMS & CONDITIONS

1. An Ordinary Member may apply to be placed in the Register of Members as a Grand Member provided that he satisfies the following conditions:
 - a) he is 70 years or more in age;
 - b) he has been a member and has been paying the monthly subscription for a continuous period of 25 years;
 - c) he transfers or sells his Ordinary membership prior to his application;
 - d) he has paid up all monies due to the Club.
2. A Grand Member shall pay a monthly subscription of one-half the prevailing subscription rate applicable to an Ordinary Member;
3. A Grand Member shall not be eligible to hold office or vote at general meetings;
4. A Grand Member shall not be eligible to subsequently transfer or sell his membership including transfer upon death;
5. A Grand Member shall maintain a refundable credit deposit of \$500 and be subject to a spending limit of \$1000.
6. A Grand Member is entitled to enjoy all the facilities of the Club.

7. Grand Members have no voting rights or power to hold office.
8. Grand Members are subject to all provisions of the Constitution and Bye-Laws of the Club.
9. The estate of a Grand Member shall be responsible for settling the debts owing to the Club at the time of his death.
10. The General Committee shall have the sole and final discretion on the acceptance of each application.
